## FEDERAL TERRITORY (PLANNING) ACT 1982

FEDERAL TERRITORY (PLANNING) (FEE FOR PURCHASE OF DRAFT  
STRUCTURE PLAN) RULES 2020

In exercise of the powers conferred by section 7 and paragraph 64(2)(j) of the Federal Territory (Planning) Act 1982 [Act 267], the Commissioner of the City of Kuala Lumpur, with the approval of the Minister, makes the following rules:

**Citation and commencement**

1. (1) These rules may be cited as the **Federal Territory (Planning) (Fee for Purchase of Draft Structure Plan) Rules 2020**.

(2) These Rules come into operation on 18 February 2020.

**Fee**

2. The fee for the purchase of a copy of the draft Kuala Lumpur Structure Plan 2040 shall be as specified in the Schedule.
