**Citation and commencement**

1. (1) These rules may be cited as the **Water Services Industry (Water Supply Services Agreement Between Consumer And Water Distribution Licensee) (Amendment of Schedule) Rules 2020**.

(2) These Rules come into operation on 1 July 2020.

**Amendment of Schedule**

2. The Water Services Industry (Water Supply Services Agreement Between Consumer And Water Distribution Licensee) Rules 2014 [*P.U. (A) 227/2014*] are amended in the Schedule—

(a) in paragraph 15.3, by inserting after the words “is supplied with water” the words “for the purposes of domestic use”; and

(b) by substituting for paragraph 20.3 the following paragraph:

“20.3 The Water Distribution Licensee shall have the right to terminate the supply of water to the Consumer’s Premises if a court declares that the Consumer has no legal right to occupy the premises.”.
